EARLY CONVERSION OF NOTES

We refer to the recent announcements concerning the Company's Early Conversion Invitation to holders of convertible notes. The Company announces that it has today completed processing valid conversion notices received prior up to 22 April 2009. This has resulted in the issue of 1,529,148 fully paid ordinary shares and the payment of \$382,287 being the cash consideration for acceptance of the Early Conversion Invitation.

At today's date 76.3% of noteholders had submitted or agreed to submit conversion notices pursuant to the early conversion proposal. The Company will update the market as conversion notices are processed and allotment is completed.
